WORK IN PROGRESS

Beauty by the Numbers. A history of rating and ranking systems in literature and the arts. Book project, in preparation.

Empirical Reader Studies. An ongoing digital data exploration project in collaboration with J. D. Porter and students at the Price Lab. We have scraped user data about thousands of fiction readers and the hundreds of thousands of books they read from Goodreads and The StoryGraph. Our analysis currently focuses on how the race of an author shapes the reception of their work on these sites.

The Eclectic Reader. An article that emerged from the Empirical Reader Studies project, focusing on the idea and the practice of “eclectic” reading in the 21st century. Currently under submission.
